

ANTI BULLYING POLICY

Basic beliefs:

Flowerdale Primary School emphasises that all members of the school community operate in an environment that is both safe and supportive, free from physical, emotional and social harassment: where individual rights are respected.

Guidelines:

Definition – Bullying is an act of aggression causing embarrassment, pain or discomfort to another. It can take many forms: physical, verbal, gesture, extortion and exclusion. It can be planned and organised. Individuals or groups may be involved.

Rights and responsibilities of the individual – At Flowerdale Primary School every person has the right to be treated with respect as a worthwhile individual and every student at Flowerdale Primary School has the right to an education in a safe environment free from bullying and harassment. With these benefits and individual freedom comes a duty of the individual to act responsibly to others and within the school community. It is the responsibility of all individuals to refrain from indulging in bullying behaviours.

Cyber Bullying

Young people have fully embraced the use of information and communication technologies to maintain contact with friends and make new ones. They send emails, create their own websites, post personal news in blogs (online interactive diaries), send text messages and images via mobile phones, message each other through IMs (instant messages), chat in chat rooms, post to discussion boards and seek out new friends in community sites.

While most interactions are positive, there are increasing reports of these technologies being used to harass and intimidate others. This has become known as cyber bullying. Cyber bullying will be treated in the same regard as any other form of bullying.

<u>Implementation strategy to deal with bullying:</u>

In order to ensure that bullying and harassment is not tolerated, we must all speak up and report cases, even at risk to ourselves.

This requires staff to:

- Be role models in word and action.
- Be observant of signs of distress, suspected incidents of bullying or bullying behaviours.
- Take steps to help victims without placing the victim at further risk.

• Report suspected incidents to the appropriate staff member who will follow up to ensure that the bullying ceases.

This requires students to:

- Refuse to be involved in any bullying situation. If present when bullying occurs he/she should take some form of preventative action and report the incident.
- Avoid retaliation. It is important to take other action such as asking the bully to stop, laughing it off or telling someone who will support you.
- Refrain from bullying behaviours.

This requires parents to:

- Be role models in word and action
- Watch for signs of distress in your child.
- Advise your child to tell a teacher about the incident.
- Encourage your child to not retaliate.
- Be willing to attend interviews at school about the incident.
- Be watchful of your child exhibiting bullying behaviours.

When teachers, students and parents work together on bullying, we can create a school environment that allows the student to maximise his/her potential without interference from others.

Rules & Consequences

Rules and Consequences are used to support our Rights & Responsibilities. This occurs via a staged response.

When a student is unable to use self-controlling thoughts to manage his/her emotions, and begins to act in a way that threatens our Rights and Responsibilities, then specific consequences and strategies are used to assist that student to take charge of him/herself.
